Considering that, your governmental communication, is and has been since January 2020, pure propaganda, by controlling the medias that you are force-feeding with Millions of dollars, so that they repeat disinformation day after day. By your stranglehold, you are installing indoctrination in governmental institutions such as; professional organizations, insurance companies, collaborative workers unions, Police forces as well as elected officials. You are refusing any and all public debates and any exchanges with the scientists who do not share your narrative. You are violating our freedom of expression and our democracy in order to install a totalitarian regime.

Considering that since March 2020, your figures on the numbers of deaths and hospitalizations caused by corona virus are erroneous. You are deliberately inflating them by adding deaths by epidemiological link. Not only are you combining other diseases to COVID, and have also forbidden autopsies. How can you distinguish deaths from COVID from deaths with COVID. This inflated statistic can only hide other intentions than to stem a virus that doesn't exist nowhere else than in computers under digital form, since the so-called COVID-19 virus and any pretended 'variants' have never been isolated nor identified in any laboratory worldwide.

It is clear that your contradictory, inconsistent and threatening messages are intended to create cognitive dissonance that leads everyone to lose their discernment. You are inducing a feeling of confusion in order to generate lethargy in the population to lead it to its own servitude and to force them to capitulate in the face of the unbelievable lie. You declared the State of Emergency to establish your mandates and rules to satisfy and dissimulate your interests in the name of a virus similar to the flu and which has never been isolated in a laboratory. You have imposed the wearing of mask, confinement and social distancing to destroy social cohesion and steal 2 years of our lives.

It is evident that, you are dividing and opposing the population to generate fear between individuals, and have strongly encouraged delation. You are ostracizing and accusing the un-vaccinated to be responsible of spreading the virus. You are trampling our Charter of Rights and Freedoms by occulting our right to free and informed consent. While you are spending our Millions for shots which do not prevent contamination nor spreading of the virus. You are hiding the negative effects and the deaths caused by these experimental injections as well as their components. You have dared to protect the pharmaceutical companies and your government from any liabilities from the injection.

Your management is a perfect example of professional scam. You have produced one thousand damages with one single interest, which was not our health nor our well being. In the history of Quebec, it is becoming more and more clear that many persons, with powers and positions within the government, are working against the fundamental well being of all its citizens.

Considering that, the un-necessary medical or scientific experiments for the medical treatment of a person contravene to Article 32 of the Geneva convention. The government has allowed the launching of a medical experiment on the population without allowing a free and informed consent. 10 articles from the Nuremberg Code of 1947, have been violated. The Nuremberg Code of 1947 identifies informed consent as an absolute prerequisite to the conduct of research involving human subjects:

1. The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs, or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.

2. The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.

3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results justify the performance of the experiment.

4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.

5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.

6. The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.

7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability or death.

8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.

9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.

10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill and careful judgment required of him, that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

It is clear that the Government of Quebec has violated federal, international and constitutional laws.

Here are the articles of law that renders all men or women of the nation, victims of our governments and their collaborators, allowing the opening of a criminal investigation, as well as of financial compensations to be determined.

- Extorsion 346(1) CC
- Intimidation 423 (1) CC
- Uttering threats 264.1 (1) CC
- Assault 266 CC
- Hateful propaganda 3 18 CC
- Public hate incitement 319 CC

The intervention by the Quebec Military Tribunal is necessary to judge all the accomplices of the Crime of the century, for which some of the details are listed below:

— Investing hundreds of millions of dollars to install a network of thousands of 5G antennas from Huawei which dangerous effects have caused millions of deaths in Wuhan in 2019, since that city was curiously the site of the first large scale test in China with 10,000 antennas, on top of being the city from where the ‘new virus’ is supposedly coming from...; ;

— Lying to the population from the start, by making them believe that there were no other remedies against covid than dangerous and deadly drugs like Remdesivir, when front line doctors and the international scientific community had demonstrated the efficacy of hydroxychloroquin, ivermectin, Artemisia annua, zinc, vitamin C, vitamin D, ozone and many more safe and natural solutions, but especially Hyperbaric Oxygen Therapy for its beneficial effects against radiation sickness caused by 5g antennas which in turn causes symptoms similar to the ‘flu’, which symptoms have been blamed on a ‘new virus’;

— Daring to push the absurdity to install one-way stickers in the aisles of grocery stores;

— Limiting the number of tables in restaurants by up to 50% in order to impose stupid social distancing with extreme damages to owners and their employees;

— Gravely affecting or outright demolishing the tourism industry;

— Forcing businesses to enforce the wearing of masks by customers in their businesses or be penalized through fines of tens of thousands of dollars, and harrasing customers who had a medical exemption against the waring of mask, even if this practice is toxic for the entire population, but that the generalized application was necessary to force compliance;

— Encouraging delation of neighbors who did not respect the limit of persons in a single home, or the regional bubble rules;

— Imposing curfews after 10pm, Quebec being the only province / state in North America to apply this measure;

— Pressuring by all means listed above the force compulsory vaccination of all men, women and children with a vaccine that is still experimental and which after several months, is clearly showing its lack of efficacy in protecting against the virus or to spread it. Especially since thousands of people have suffered very serious negative effects and in some cases death. According to document by the FDA unsealed under the order of a U.S. federal judge in March 2022 which was produced in april 2021, the dangers of the experimental vaccines /injections is clearly demonstrated;

— Causing the death of several thousands of elderly persons in retirement homes, leaving them in agony in their urine and feces, in the worst kind of loneliness and despair;

— Preventing families to visit their parents who were isolated in their rooms at the retirement homes, and not being able to manage the funeral once they were dead;

— Imposing COVID protocols with dangerous drugs like Remdisivir as well as the use of risky respirators which have caused the death of thousands of old people in retirement homes and hospitals;

— Traumatizing children, teenagers and young adults, by potentially holding them responsible for the death of their parents and grand-parents;

— Squashing and raping the Charter of Rights and Freedoms of the People, as well as trampling on the constitution and seizing power for the profits of the pharmaceutical companies;

— Destroying the real economy, that of the self-employed workers, that of the small and middle size businesses by deciding in an arbitrary manner what was essential or not;

— Manipulating the people of Quebec by using the worst social engineering techniques to threaten, blame, submit, and constrain the weakest among us;

— The journalists from the mainstream media for planting the seeds of violence and division at the heart of families, associations, churches, and businesses by calling conspiracy theorists any person who was looking for the sense and the truth in the middle of this sea of lies;

— The insurance companies for imposing the respect of the pseudo-sanitary measures in every businesses, otherwise they would stop covering them;

— The leadership and the agents of the 'Sûreté du Québec' (provincial Police) and all other Police forces for not respecting their oaths of protecting and serving the population, trampling and violating the Charter of Rights and Freedoms of the People, flouting the constitution and being an accomplice of division, discrimination and segregation of the People of Quebec;

— The 'Sûreté du Québec' for distributing thousands of fines for not respecting the wearing of mask or for not wearing it adequately in order to cover the nose;

We, a group of international lawyers and a judge, hereby are conducting criminal investigation modelled after the United States Grand Jury proceedings. This Grand Jury Investigation serves as a model legal proceeding to present to a jury (consisting of the citizens of the world) all available evidence of COVID-19 Crimes Against Humanity to date against "leaders, organizers, instigators and accomplices" who aided, abetted or actively participated in the formulation and execution of a common plan for a pandemic. Crimes to be investigated include all acts performed or omitted by a person in pursuance of a common design to commit Crimes Against Humanity, and all such criminal acts condemned in the various communities of jurors around the world.

This investigation is of the people, by the people and for the people and shall be referred to as the 'Peoples' Court of Public Opinion. Having been unable to find a court to hear the actual evidence in the current system's courts of law, we are undertaking this proceeding outside of the current system and based on natural law. This, in turn is founded on the firm belief that every person can easily distinguish between good and evil, and between right and wrong.
